CSC's leadership is recruiting a Bid & Hosting Committee Chair. Next step, Chairs populate their committees.

5.2 Sport Canada's Sport Support Program

An update was provided about the recent "modernization" of Sport Canada's Sport Support funding program. The key takeaways include:

- 1. This funding program is based on need instead of a core reference level which was guaranteed each year.
- 2. Any National Sport Organization can apply, not just only those already funded.
- 3. No new money is available presently.

Organizations can apply for 1 to 4 years of funding Funding decisions are expected in March 2025





Commonwealth Sport Canada's funding request includes, in order of priority; Team Canada, Sport for Newcomers, Women Coach Intern Program (WCIP) and Back of House Governance & Administration

Applications are due December 11, 2024.

5.3 United Canada 2030 Commonwealth Games Bid

After many unsuccessful games bid attempts in Canada, CSC is trying something different. Aligning with the CGF's "Games Reset", including co-hosting and reduced operational costs, CSC has met with provincial/ territorial governments to present CSC's proposed multi-province 2030 Commonwealth Games model, including provincial governments selecting the sports and their locations.

Next steps include: Contacting FCM to help get the word out to municipalities and follow up with provincial governments in January 2025. Interested provincial governments are to submit their expression interest with their preferred sports and an Indigenous component in February 2025.

5.4 Sport for Newcomers

With the successful launch and implementation of the Sport for Newcomers pilot program back in 2020, Commonwealth Sport Canada Foundation is working on a partner recruitment package including a video and handout. The package is expected to be ready to market by the end of year or early in the New Year.

5.5 CGF and Team Canada 2026 Update

A brief update on CGF activities was provided:

- The 2026 Commonwealth Games in Glasgow will be smaller, hosting 10 sports in four (4) existing venues within an 8 mile radius. Team members will be housed in hotels. The 2026 Commonwealth Games are funded by CGF using funds received from Australia's withdrawal.
 CGF is playing a larger role than usual in organizing the Games and has redirected several of their staff to this purpose.
- An Expression of Interest has been distributed for the Commonwealth Youth Games in 2027 and noted that the Youth Games could move to every 2 years.

Team Canada 2026:

- Kelly Laframboise has been hired as Team Canada 2026 Director, effective January 1, 2025, through September 30, 2026. Chris Taylor will transition into the position of Programs & Operations Manager, effective April 1, 2025 and hire a Programs & Operations Assistant by April 1. This is a great opportunity for CSC to hire from within with two well experienced staff. Kelly & Chris led the teams into Bahamas (2017) and Trinidad & Tobago (2023) doing a great job.
- It is estimated Canada's team size be approximately 135 athletes and 65 officials (Coaches, Managers, Mission Staff) for a total team size around 200. In the past, the team size was around 400.
- A Call for Mission Staff could be distributed early in the New Year.





6. OTHER

A virtual Board Meeting will be scheduled for March 2025 and development of CSC's next Strategic Plan will restart in May 2025.

7. IN CAMERA

The Board of Directors conducted a regularly schedule In-Camera meeting.
